The Institute of Social Studies Trust (ISST), a non-profit, non-governmental organisation, was registered as a Trust in 1980. ISST's overall aim is research for social change with focus on work and well-being from a gender perspective. In recognition of its work, ISST has been conferred NGO Consultative Status (II) by the United Nations.

ISST attempts to bridge the gaps between research, action and policy debate, believing that academic research can provide valuable inputs into grassroots activism and policy debate, but equally that activist experience and policy concerns need to influence the directions of research. ISST, thus, positions itself at the interface between research, action and policy.

The head office of ISST is located at the India Habitat Centre in New Delhi. ISST has a Community Outreach Programme in East Delhi and a branch office in Bangalore.

Institute of Social Studies Trust is a Public Charitable Trust registered with the Sub Registrar, New Delhi, vide registration No: 923 dated 25 February, 1980 having its registered address at Core 6A, UG Floor, India Habitat Centre, Lodi Road, New Delhi 110003.

MESSAGE FROM THE CHAIRPERSON





The year 2010-11 has seen ISST actively engaged in several evaluation studies, and reflecting across evaluations. In the coming years, we expect to address policy and programme dilemmas through the lens of evaluation, and build up appropriate methods from what has been ISST's strength i.e. a gender-sensitive and participatory approach to research. It is a matter of satisfaction that ISST has built up a network of persons including researchers and feminist activists who could jointly work towards equity and inclusive development.

An annual report is the space to reflect on what has been achieved, and where the shortcomings were. Overall, the research, publication and dissemination activities at ISST have been well accomplished. All projects taken on have been successfully completed, and several have led to publications as well. ISST has continued to work in partnership with grassroot groups, with strong fieldwork in most studies.

It is particularly good news that as we move into the year 2011-12, we do so with support from the SDTT for a three year programme with women domestic workers, a recognition of the sustained good work done by the community centre team over the last decade. The not-so-good news concerning the overall financial situation possibly calls for some difficult decisions. We expect a year of some re-structuring and review to deal with this aspect.

MESSAGE FROM THE DIRECTOR





Over this last year, through its efforts at research, action, writing and communication, ISST has continued to explore the complex interactions between gender, economics and empowerment, and to build up a body of knowledge around these concerns.

The Indian economy, as is well known, is dominantly informal, and so is most newly generated employment. Recognising this, and recognising the significance of this informality for work-conditions and worker-benefits that women are able (or unable) to access, we have

been encouraged to continue to research on women in the informal economy. We have sought to do so in ways that step outside disciplinary boundaries, that experiment with innovative research methods, respond to issues emerging from the field, recognize the role of experiential learning, and are accountable to the larger community.

It is often argued that it is systems that generate success or failure, and that macro analysis and design are therefore more necessary than a focus on the individual case- such cases are seen as 'anecdotal'. But the 'bottom up' approach that we have favoured requires that we start from the individual case, because it recognizes that anecdotes add up to accumulated experience and eventually the hard data that constitutes 'knowledge'. In a country with vast differences of geography, occupation, class, caste and gender, the aggregated macro picture can easily miss the nuances that contextually differentiated approaches would appreciate.

Another area of concern is the frequently large gap between the intentions of programmes/policies that seek empowerment (itself an elusive concept), and their actual outcomes. It is our belief that evaluations and evaluative studies offer a potentially very valuable means of understanding this shortfall. We have therefore undertaken a large number of evaluations, each one complete in itself, and together contributing to a larger canvas of knowledge. Thus, in the coming year, we expect to be able to distill these aggregated experiences into sharp messages, addressed both to policy makers and to programme implementers and indeed to ordinary people themselves, whom we see as being equally agents of change.

This annual report reviews the specific areas of ISST's work in the last year. While we have remained vulnerable to delays in approval and fluctuations in project funding, the commitment of our team—towards excellence in output and integrity in effort has not wavered. We are grateful as always to all our donors and other supporters of our work, and to the Trustees for their encouragement, and we hope to better fill the gaps between our own intentions and achievements in the years to come.

EXAMINING THE NREGA - WOMEN'S PAR-TICIPATION AND IMPACTS IN HIMACHAL PRADESH, KERALA AND RAJASTHAN

This research examines women's participation in the NREGS (now MGNREGS) in selected areas in three states: Kerala, Himachal and Rajasthan. The Employment Guarantee Scheme has succeeded in bringing large numbers of women into paid work, many of them for the first time. The study explores the complex reasons why women's participation in the scheme varies significantly across and within states, and suggests that minor changes to the scheme, to address local development challenges and priorities, could deliver better outcomes. This study was sponsored by Social Protection in Asia (SPA) programme at the IDS, Sussex. The study is based on fieldwork carried out by Grace Fernandes, Rina Bhattacharya, Madhuri Karak and Ratna Sudarshan. THE POLICY RESEARCH ENVIRONMENT AND POLICY RESEARCH ORGANIZATIONS SOUTH ASIA

The 'Think Tank Initiative' (then by the William and Flora Hewlett Foundation, the Bill and Melinda Gates Foundation, and IDRC) supported a scoping study on the policy research environment in South Asia carried out in partnership with ISST. This included the preparation of background papers and three Roundtables. The papers prepared at or through ISST include 'Social Science Research in

South Asia - An analysis of the published journal literature' by Subbiah Arunachalam; 'Policy Research and Practice in India' by Ratna M. Sudarshan; and 'Policy Research Organisations: Projecting Successful Performance in the South Asian Context: an Analysis of Annual Reports and Websites' by Anuradha Bhasin and Mubashira Zaidi.

Three country level Roundtables/dialogues were organised with social science and policy research organization leaders from Bangladesh, India, Nepal, Pakistan, and Sri Lanka over the period December 2008-March 2009 in Puducherry, India; Galle, Sri Lanka; and Kathmandu, Nepal. A summary of the roundtable discussions, 'Making Research Matter in South Asia' by Katherine Hay and Ratna M. Sudarshan_has been published in the Economic and Political Weekly.

GENDER AND PARTICIPATORY DEVELOP-**MENT: EVALUATION CONCERNS**

The project supported reflective writing around evaluation by a group of feminist researchers and a workshop on Gender and Participatory Evaluation was organized by ISST on August 26-7, 2010 in New Delhi. This workshop focused on the ways in which a gender sensitive/feminist lens could be used to strengthen the role of evaluation in the social change process. It highlighted the perspectives of a set of gender equality advocates and social science researchers who have also been engaged with evaluation studies over the years. Six background papers were discussed at the workshop, by Vimala Ramachandran, Renu Khanna, Ranjani Murthy, Kameshwari Jandhyala, Radhika Govinda, and Ratna Sudarshan with Divya Sharma. Some of the papers were subsequently presented at the European Evaluation Society Conference in Prague, and the

Evaluation Conclave in Delhi. A training workshop was also conducted based on these studies at the latter event.

An edited set of the papers has been accepted for publication as a special issue of the Indian Journal of Gender Studies.

REVIEW OF THE GREEN JOBS PROGRAMME IN INDIA

This review of a pilot project on Green Jobs of the ILO sought to assess what progress had been made in facilitating the development of a policy instrument that would put national policy and consensus on green jobs into practice, and to what extent the project has been able to lay the basis for an expansion of green jobs programme in the country. Further the review makes some specific recommendations for future direction of Green Jobs interventions in India and documents lessons learnt in regard to design and implementation. The review is focused on the interventions within India, and takes note of the global/inter-country developments.

The review, conducted by Ratna Sudarshan, was discussed at a Stakeholders Workshop in September 2010.

EVALUATION OF STEP PROJECT : MUSHROOM CULTIVATION IN HARYANA

A concurrent evaluation of this project was conducted and the report submitted to the Ministry of Women and Child Development, Govt. of India. The project supported training for Mushroom Cultivation through a grant from the STEP programme to the Haryana Nav Yuvak Kala Sangam (HNYKS) in Rohtak district. The evaluation team included Rina Bhattacharya and Swati Gupta, who

visited 9 villages for data collection. A total of 273 women were interviewed during the evaluation. Apart from the questionnaire survey, discussions were held with different groups of beneficiaries.

BASELINE AND END LINE STUDY TO ASSESS THE IMPACT OF SEWA BHARAT'S WORK IN DELHI

Following the baseline study conducted in 2008, an endline study was conducted in November 2010 and an assessment made of the impact of SEWA Bharat's work in Delhi in the areas of capacity building and promotion and protection of livelihoods with street vendors, construction workers and home-based embroidery workers. The team for the endline study was led by Rina Bhattacharya.

REVIEW PAPER ON HOME-BASED WORKERS

An overview paper reflecting on the data and issues related to home-based women workers in South Asia in general and in India in particular has been prepared by Ratna Sudarshan, ISST and Shalini Sinha, WIEGO, and published as a Research Report by WIEGO under the Inclusive Cities project. UNDP-PLANNING COMMISSION PROGRAMME ON HUMAN DEVELOPMENT

A final end of project evaluation of the UNDP-Planning Commission programme on Human Development in India was carried out by a team including Meera Pillai, Manabi Mazumdar, Anu Bhasin, Meenakshi Ahluwalia and led by Ratna Sudarshan. This evaluation, at the conclusion of ten

years of active engagement of the UNDP with operationalising the concept of human development in India, was carried out based on review of a sample of outputs, interviews with a range of stakeholders and field visits to five states, Himachal Pradesh, Kerala, Madhya Pradesh, Rajasthan and West Bengal. The evaluation responded to a few key questions on the importance and relevance of the system of HDRs to UNDP and to India's national and state priorities; Govt. of India and UNDP's approach in mainstreaming human development at national, state and district level in formulating policies, planning and implementation etc.

EVALUATION OF STEP PROJECT: ZARI ZARDOZI PROGRAMME OF ADARSH MAHILA KALYAN SHIKSHA SAMITI, ALLAHABAD, UTTAR PRADESH

This concurrent evaluation of a training project on Zari Zardozi work was conducted by Shubh Sharma and Navika Harshe, who visited all five locations where the women are currently engaged in production after receiving training. A total of 83 women were interviewed in a questionnaire based survey, and a number of focus group discussions were held with different groups of beneficiaries and the key personnel in the project management.

A STUDY OF THE BACHPAN PROGRAMME AT COMMUNITY CENTRE, ISST

ISST Community Outreach Programme in East Delhi runs a programme for children intended specially for those under six years of age. The aims of the present study are to explore the extent to which the programme helps mothers (i.e. taking care of children while they go out to work, freeing up time for house hold chores, etc.); to document the efficacy of the programme and to identify areas where there is a scope for improvement. Largely based on direct observation and interviews, this study was carried out by Swati Gupta and Aliya Hamid Rao.

ROADMAP FOR GIRLS' EDUCATION 2015

This project includes the preparation of an annotated bibliography, which has been done by Shubh Sharma, a review paper by Ratna Sudarshan and Shubh Sharma, and a 'roadmap' which will build upon recommendations emerging from literature review and UNICEF staff experience, as well as inputs from Government and academia, and this latter is currently being finalized. The Roadmap for girls' education is intended to identify specific actions and approaches to advance gender parity and equality in, within and through education across India.

REVISITING **EDUCATION** FOR ALL (COMMUNICATION AND DISSEMINATION)

Following on the completion of the re-visit study of the PROBE survey of 1995, a series of state level workshops is planned to disseminate findings of the Revisiting Education for All study. Additional analysis of data is to be supported through a fellowship programme. This project is being implemented by Anuradha De, Meera Samson and other researchers.

BASELINE AND END LINE STUDY FOR STREET VENDORS IN AHMEDABAD CITY (SEWA UNION)

To assess the impact of SEWA's work on the socio-economic and working conditions of street vendors in Ahmedabad city in the areas of capacity building and promotion and protection of livelihoods with street vendors, through a project titled "New Strategy of SEWA: To Save the Livelihoods of women street vendors in the Era of World Class Cities", Mahila SEWA Trust has commissioned ISST

to conduct an impact study through baseline and end line survey. The report on the baseline survey in 2009 was written by Shrayana Bhattacharya and Divya Sharma and the endline will be completed in 2011.

ASSESSMENT IMPACT OF PROSVIL INSTITU-TIONAL GRANT (SEWA ACADEMY)

ISST has been entrusted to conduct a concurrent evaluation of the various training activities to be carried out by SEWA Academy under the 3 year PROSVIL project. This is being done in a participatory manner with an aim to strengthening and improving the content and methods of training, and addresses any challenges as they are noted. In the first year, perceptions of trainers were recorded through a questionnaire, a sample of trainees was met in groups, supplemented by discussions with the SEWA Academy team, and direct observation though field visits to some of the training venues. The ISST team is led by Rina Bhattacharya.

DEVELOPMENT AND PEACE-TRAUMA. BUILDING: PSYCHOLOGICAL PROGRAMMING AND SOCIAL TRANSFORMATION (A CASE STUDY OF KASHMIR)

It is recognized that political violence inflicts trauma and suffering on individuals and communities and that it is often built upon and woven into systemic violence. In order to achieve lasting peace, post-conflict reconstruction must address the impact of direct violence as well as those aspects that constitute structural violence. The objectives of the Kashmir case study, being conducted by Shobhna Sonpar, will be to determine whether and

how psychosocial programs within a context of political violence influence social transformation that

contributes towards peace and development. Supported by INCORE/University of Ulster.

LOOKING AHEAD

As we enter into the next financial year, we are pleased to be doing so with a grant from the SDTT that supports a programme of action and research with women domestic workers over the next three years. This project builds upon the findings of the study on domestic workers carried out at ISST over the period 2008-9, as well as the experiences of the Community Outreach staff. The Community Centre programme will identify and address problems of women domestic workers, their children and households, in and around Kalyanpuri, East Delhi, either directly or in partnership with the ISST Gender Resource Centre supported by the Delhi Government to enhance access to government services and entitlements. ISST will also play a co-ordinating role in pulling together the experiences of a group of organizations across the country being supported by SDTT to work with domestic workers, by convening annual workshops and documenting the various experiences.

Through greater attention to the theory and practice of evaluation and feminist perspectives in evaluation, we hope to develop in the coming year a programme of research and training that would strengthen evaluation capacity among a group of social science researchers including those at ISST, develop stronger methods and practices in feminist evaluation, connect research with evaluation findings, and communicate stronger messages to policy makers.

Other research projects continue to be largely focused on women's work, the informal economy and education.

COMMUNITY OUTREACH PROGRAMME



ISST's community outreach programme in a few slum communities of east Delhi is now 10 years old. The programme has been actively associated with extending information about, and use of, the Right to Information (RTI) as a tool for accountability. The table below, based on analysis of 176 applications filed over a 12 month period during November 2009-October 2010 by residents in and around Kalyanpuri, East Delhi, suggests that the agencies that people reach out to most often are the Municipal Corporation of Delhi (MCD) and police, and that resort to RTI becomes necessary to obtain ration cards or income certificates, in particular. The RTI has become a necessary tool even to get responses and support for ordinary and everyday problems, and support that should be forthcoming in the normal way.

active centre through the year, with regular discussion groups, workshops, theatre, film club, non-formal education, computer training etc.



COMPUTER AND **FUNCTIONAL ENGLISH** TRAINING PROGRAMME

ISST Saathi Centre at Kalvanpuri offers two programmes: Six-month Certificate Course in Basic Computer Literacy and Six-month Certificate Course

> in Functional English Language. The certificates are awarded by ISST on successfully completion of the course. In December, around 75 students appeared for the final examination in computer literacy and functional English programme. At present 75 students are enrolled for the courses.

> A decision was taken this last year to withdraw from the IGNOU Community College scheme for now, as there had been some lack of clarity on the qualifications of trainers under this programme as a requirement for participation.



Amita Joshi and Md. Ashkeen Ahmed conducted a two-day workshop on RTI at Almora in August 13-14 2010 at the invitation of the Uttarakhand Sewa Nidhi Paryavaran Shiksha Sansthan. This was attended by 50 participants from 25 villages in Uttarakhand.

The Youth Resource Centre has continued to be an

ISST-GRC started in October 2009. In the last one year, the centre saw an upsurge of interest by the community regarding the various services available

through the GRC, which include health camp, nutrition camp, health clinic, legal counseling, Self Help Groups, non-formal education, adult literacy and vocational training courses (beauty culture and cutting and tailoring). Most of the children who participate in ISST-GRC's non formal education program are either school drop-outs or had never been admitted to a formal school previously. A number of children joined open school after completing the program. Till date, ISST's GRC has formed six self help groups. Three groups are already affiliated to nationalized banks.

Having noted that women domestic workers are a significant proportion of the women in the community, and that they, and their children and households, need support in various ways, from April

2011 the Community Programme will have a special focus on this group. ISST will also play a co-ordinating role to enable networking among a group of organizations working with women domestic workers across the country, with support from SDTT.

WOMEN'S EMPOWERMENT OR DOMESTIC DISCIPLINE? RECONCILING THE EVIDENCE ON FEMALE EDUCATION, GENDER EQUALITY AND CHILD HEALTH IN HISTORICAL AND **CONTEMPORARY POPULATIONS:**

IN MEMORIUM - RINA BHATTACHARYA



In Memorium



Rina Bhattacharya 23.12.1959 – 08.07.2011

Rina obtained an MA in Psychology from the University of Delhi in 1982, and a PhD in Psychology in 1990. She joined ISST in 1987 as a Senior Research Associate, was Research Co-ordinator from 1993, and Research Fellow from 2007. At ISST, she carried out a range of studies. Her area of focus was women, work and poverty; her skills included quantitative and qualitative techniques, questionnaire preparation and conducting survey, project-coordination, report writing, and conducting trainings. Since 2006, she took the responsibility of following the progress of the MGNREGA programme, especially in Rajasthan. She was working closely with SEWA Academy over the last year. Apart from research, she gave oversight to the library, and kept in touch with much of ISST's informal network.

REMEMBERING RINA BHATTACHARYA - AN EXEMPLAR **DEVAKI JAIN**

Building institutions particularly what is called autonomous, small, - generated by some issue is always challenging - wherever it is birthed. Even more challenging is the process of sustaining the institution with the same ethic/culture of shared space and open doors.

While money - funds - and space are a critical aspect of sustaining such entities what is the most critical is the quality of the personnel, the individuals who work in the centre. While the current trend amongst institutions big or small, economic or social is for mobility, - for small, fragile but dedicated study centres, commitment to 'stay put', continue with the institution through its troubled times, its fragilities is the most crucial 'wealth/ resource'. But doing that requires something beyond mere loyalty. It requires a certain 'love affair' with the institute coupled with a sophisticated sense of gratitude for what the institute has provided to the person.

Such combinations are rare in today's seeking-better-opportunity culture. Hence our experience with a colleague Rina Bhattacharjee who was a Shining Star in what is otherwise a somewhat fractured atmosphere for such institutions.

Rina Bhattacharya who passed away on July 8th in Delhi was a PhD student at Delhi University when she was introduced to me by the Secretary [Culture] of that time Mr. Veeraraghavan. Mr. Veeraraghavan said to me, "here is this young girl who comes from a family which requires support and cannot continue her PhD work unless she can also earn. She requires many more skills than she has right now but she is unique in her seriousness of purpose and extraordinary humility. Can you meet her?" Sure enough a very young but not at all diffident, young woman presented herself to me and one could see straightaway that she had yet to master writing in English, get introduced to what is called the data. What was, however what can be called her USP was the affection and friendliness that poured from her eyes. It was like she was saying "Try me" without saying it. Rina Bhattacharya joined ISST and soon her colleagues began to find her most valuable as she was willing to help anybody on anything that they needed. She was a friend to the librarian, she was a support to the already existing researchers, to the accountant and always willing to go out to other libraries departments or centres to bring back what was needed at that time by ISST.

But her 'burden' - never brought to reduce her commitment to the time and the outcome of the institute always there in the anxiety and weariness in her eyes was the responsibility of providing for her family. During the course of her several decades with the institute she was nursing her father, her brother, trying to help her sister find happiness in marriage, apart from long battles with her own health.

Yet almost every person who ever passed through the portals of ISST not only knew her but always commented that she welcomed them and was willing to help them in whatever way they wanted. She was ISST or its persona.

As she became senior, from being a research associate to research coordinator to research fellow, over the years 1987 to 2007, and others joined either as interns or as junior staff they found her the most helpful in getting them absorbed into the culture of the place. When leadership changed she was the strongest hand to the new leader.

It is such people who can make a small centre continue or perish as institutional memory is not so much what the computer holds but what the individual holds. It is like bringing up an adolescent into adulthood and for the small centres who do not have a huge bureaucracy what maintains its history, is individuals who contain the institution's history.

Rina got her PhD while working at ISST. When I visited her home to mourn her death with her family I felt even greater regard for her, a family of dependents were living in extremely humble set of rooms, far away from the office of ISST. How she could cope with that habitat yet do a PhD, yet come to office looking fresh and tidy, alert and willing was her grit. As she lay getting deeply unwell, I am sure she was thinking of how her mother and her unmarried sister will cope with life. Salut, dear dear Rina
